- Tighten the screws with the specified torque in this document.

  For details on power supply and wiring, refer to PRECAUTIONS FOR SAFE USE on the INSTRUCTION SHEET of the dedicated controller (FLV-TCC3HB /-TCC1EP , FLV-ATC 0405-).
- When connecting or disconnecting the lighting connector, be sure to turn off the power of the unit. Not doing so may result in malfunction.
- The temperature may reach 70°C while power is being supplied under thermally neutral environment. Do not touch the product directly. Be sure to wear heat-resistant gloves
- High-Voltage lines and power lines must be wired separately from this product. Wiring them together or placing them in the same duct may cause induction, resulting in malfunction or damage.

  • Take sufficient safety measures such as fail-safe circuit to use the product.
- Do not use in safety circuits for atomic energy or that are critical for human life. · Do not attempt to disassemble, deform by pressure, incinerate, repair, or

### PRECAUTIONS FOR CORRECT USE

Observe the following to prevent failure, malfunctioning, and adverse effects on performance and the device.

1. Installation site

- Do not install in the following locations:
- Locations where the ambient temperature exceeds the rated temperature range.
- Locations subject to sudden temperature changes (where condensation will form).
   Locations where the relative humidity is below or above 35 to 85% RH.
- Locations where there are corrosive or flammable gases.
- · Locations where there is dust, salt, or iron powder.
- Locations where the device will be subject to direct vibration or shock.
- Locations where there is strong scattered light (laser light, arc welding light, ultraviolet light, etc.)
- Locations exposed to direct sunlight or next to a heater.
- Locations where there is splashing or spraying of water, oil, or chemicals.
   Locations where there is a strong electrical or magnetic field.
- 2.Maintenance
- Do not install the product close to high-voltage devices and/or power devices
- in order to secure the safety of operations and maintenance.

   When this product and a cable are attached or removed, be sure to turn OFF the power of the Controller first before operation.

After turning on the power supply, allow the controller to stand for at least 30 minutes before use. As the circuits are unstable immediately after power on,

brightness may gradually change. 5. Lighting electricity

Lighting electricity for lighting equipment to be connected to the Lighting Controller is limited. Be sure to check the lighting electricity written on the plate of the product, label of the packaging box or this manual to connect a lighting within the specified value.

6. Static Electricity LEDs are easily damaged by static electricity. A grounded wrist strap should thus be used when installing or conducting maintenance on the Diffusion Board

7. Mounting to Telecentric Lens When using the product mounting to the telecentric lens, do not tighten the lighting mounting screw too much. Doing so may reduce the brightness due to the stress on the product.



Align the positions of "the tab of the connector at the lighting cable" and "protrusion of the lighting connector at the lighting controller", and then insert it until it clicks.




#### Removing

Hold "the tab of the connector at the lighting cable" in the arrow (←) direction and pull it straight.



Do not pull out with excessive force without pressing the tab.




